RULES AND INFORMATION:

1. All vendors must display in their allotted space only. If cover is provided, it must not protrude into adjacent spaces.
2. Setup shall be done during scheduled times only. Vendor shall not remove items from the craft show until after 6:00 P.M. on Saturday. All items must be removed Saturday.
3. No offensive items may be sold and the craft show coordinator may determine that items may not be sold or eject a vendor from the show.
4. Vendor is responsible for all Illinois sales taxes.
5. Vendor must provide tables and chairs (and cover, if desired, and recommended).
6. Spaces may not be sublet.
7. We wish to limit the selling of too many of the same items; therefore, the craft show coordinator reserves the right to deny space at the show.
8. No animals are allowed in the craft show area.
9. Vendors are responsible for removing their own debris, trash, boxes, etc.
10. When setting up, PLEASE be courteous to other vendors. Unload vehicle and then immediately move it. All vehicles must be moved from the craft show area by 11:30 A.M.
11. When tearing down, PLEASE be courteous to other vendors. Have all items ready to load before you get your vehicle. Load and then immediately move it to allow other vendors to move in to load. Vehicles may not come into the craft show area before 6:15 P.M.
12. The consumption or storage of alcohol by a Vendor is prohibited. Loud and/or obnoxious language will not be tolerated. This is a family event.
13. Spaces will be filled on a first come, first serve basis. If no space is available, you will be placed on a waiting list.
